Sub: Central Sector Scholarship Scheme by MHRD, for students enrolled in Academic Year 2017-2018

It is to inform all B.Tech. **I Year and II Year** students belongs to category (Gen/SC/ST/SBC/OBC) that the process to fill online application form for central sector scholarship has been started on website www.scholarships.gov.in. All eligible students are advised to fill online form & submit the copy of filled form alongwith supporting documents in student section latest by 07th November, 2017.

The last date for online application filling (Fresh & Renewal) is 31st October, 2017.

Eligibility for Scholarship: -

1. Candidate must be an Indian citizen belonging to non-creamy layer.
2. Academic Qualification Candidate must have passed the class 12th examination (Senior Secondary Certificate Examination 2017) conducted by RBSE, CBSE ISC of any of the state boards of India.
3. Candidate must secure 80% of above marks in class XII exam 2017 with having subject (PCM) for all categories (Gen/SC/ST/SBC/OBC) to apply for fresh Scholarship
4. Students who have completed class XII in the academic year 2016-2017 and who are in the top 20th percentile merit list of class – XII result of concerned board are eligible for fresh scholarship.
5. Candidate must have taken admission in a under graduate regular course in any recognized Indian University/Institution.
6. **Family Annual Income:** Through all sources, the total annual income of candidate's parents must not exceed by Rs.6 lakhs per annum.
7. Candidate should not belong to creamy layer and must not be availing any other scholarship.

Renewal of Scholarship: -


1. Candidate who have received scholarship in last year under this scheme.
2. Candidatas have to fill an online renewal form to renew their scholarship.
3. Scholarship will be renewed only when the candidate have passed with a minimum aggregate of 60% marks in all the subjects in two preceding semester examination or annual examinations.
4. Candidates also have to achieve the target of 75% attendance while avoiding punishable activities because if in any case scholarship is cancelled, is will not be renewed.



List of Documents Required:-

1. Under Graduate Course joining report duly signed and stamped by the head of the institution from where the course is being pursued.
2. Original copy of parents income affidavit which should be either in Hindi or English on the prescribed format on a non-judicial stamp paper of Rs.100/- duly sworn in before Notary Public/First Class Executive Magistrate/Revenue Officer (write online registration no. on its top).
3. Duly signed online generated application form (write online registration no. on its top).
4. Copy of Mark sheet of Sr. School Certificate Exam – 2017 (write online registration no. on its top of mark sheet).
5. Copy of Caste Certificate, if applicable (write online registration no. on its top).
6. Income Tax Returns / Form – 16 of both the Parents (of the year ending March 2017 issued by the employer should be attached along with the affidavit wherever applicable).
7. Copy of Aadhar card Linked with bank account.
8. Copy of Domicile certificate.
9. One cancelled cheque of personal / saving account or photocopy of front page of bank passbook (which is used for scholarship) bearing account number and NEFT/RTGS code.
10. Hard copy of online application signed by the applicant.
11. Original receipt of Tuition Fee Receipt, showing clearly and separately the amount of tuition fee paid.
12. Copy of Bank Pass Book showing name of the student, Account number, IFSC code and Photograph pasted at appropriate place duly signed by Manager with rubber stamp of Bank affixed (mandatory)
