- Tax-Related Investment Strategies

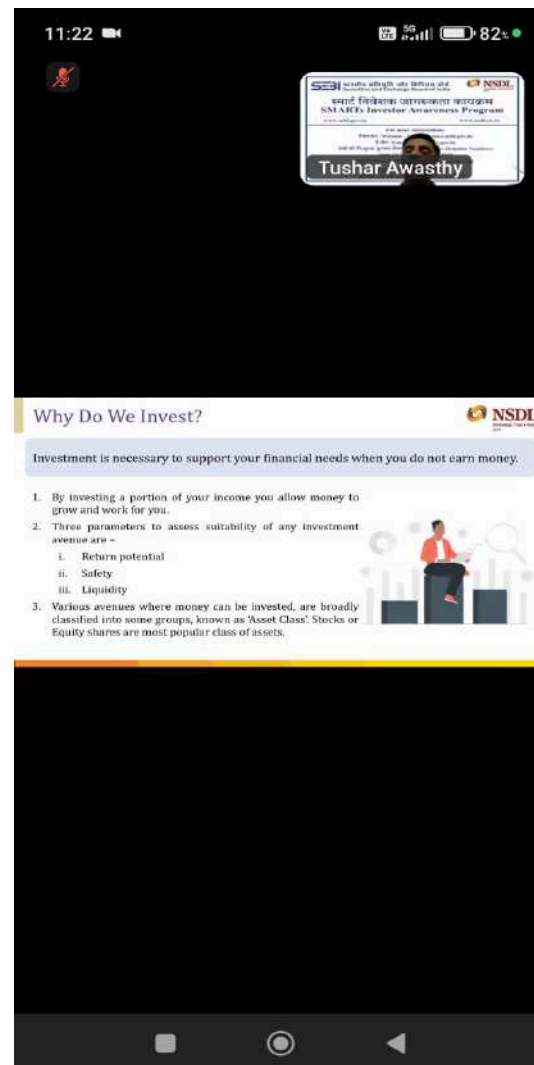
### **Program Details:**

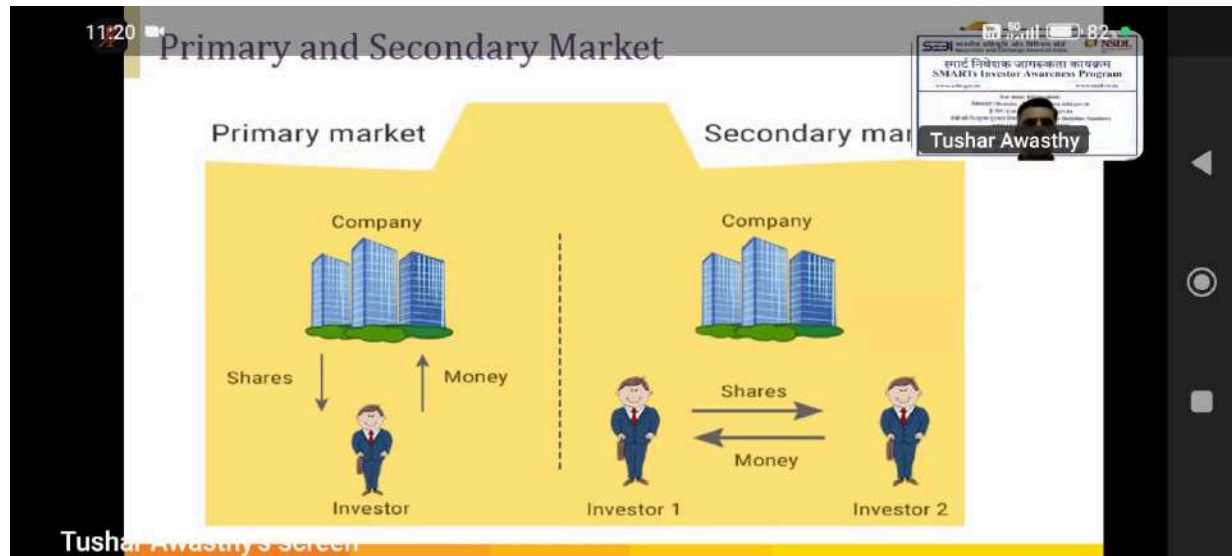
